<b>6.職務内容 Duties</b>  <p>Spreads clean linen and sets table with silver ware, glasses, sugar bowls, and salt and pepper shakers and napkins. Takes orders for food from guests and transmits orders for hot foods to a cook or to a steam table attendant. Obtains breads, butter, fruits, from appropriate stations in food service department. Carries food and beverages to tables. Serves food in individual dishes to each diner “family” style service. Removes empty dishes at end of each course and serves the succeeding course. At conclusion of meal, brushes crumbs from table cloths, carries or wheels dishes to dishwasher and set the table for the next diner.</p> <p>Wipes glasses and silverware. Cleans, organizes and arranges dishes, service utensils, silverwares, etc. Maintains a neat, tidy and orderly work area. Sweeps dining room floor, dusts dining room furniture and furnishings, and removes, sorts, records and packs soiled places of table linen for laundry. Responsible for setting, resetting and restocking adequate supplies for the working station. Stands by and refills beverage at the back of the house. Picks up any necessary beverage and food item from other Food &amp; Beverage outlets in the hotel. Fills out Internal Transfer Form and give it to the supervisor for him/her to place an order to transfer regular stock items from warehouse to food outlets and maintains bar supplies.</p> <p>Processes payments, balances sales and receipts according to the Navy regulation and procedure. Maintains accurate records of transactions. Processes sales using MICROS.</p>
