Under the Recreation Manager (Athletic Instructor), responsible for the operational supervision of the lifeguard staff and recreation assistants, ensuring the safety and smooth operation of The Edge (Fitness Center, Swimming Pool) and recreation programs. This position involves training, supervision, facility maintenance, and program development to enhance guest experience and safety. Ensure proper execution of water safety procedures, rescue techniques, and emergency response. Ensure proper gym procedures, response. Conducts monthly CPR and rescue training sessions to maintain lifeguard-Rec-Assistants readiness. Trains and leads staff in STAR customer service Ensures compliance with operational procedures, including pool opening hours, safety protocols, and guest services. Ensures staff coverage and proper execution of responsibilities. Conducts ongoing training and mentorship to enhance team skills and performance. Assigns and reviews work, adjusts schedules, and manages workload changes as needed. Monitors compliance with policies and procedures, taking corrective action when necessary. Patrols the entire Edge AOR area to prevent accidents, ensure cleanliness, and enforce safety regulations. Supports, organizes, and supervises aquatic and recreational programs, including group and individual exercises. Evaluates program effectiveness through surveys and patron feedback, recommending improvements or modifications. Assists in organizing and setting up recreation events, including Mind, Body, and Mental Fitness (MBM) Maintains records of incidents, rescues, training logs, and staff certifications. Assists in managing financial transactions related to recreation services, including cash handling. Ensures proper accountability of property and supplies within the facility. Conducts routine inspections of Edge equipment, ensuring proper maintenance and safety compliance. Reports and logs facility issues, submitting service requests for necessary repairs. Manages inventory, including chemicals, towels, pool toys, and fitness supplies. Fixed Asset representative for the Edge. Performs other related or incidental duties as assigned.
