Occasionally bakes, braises, or fries vegetables in deep fat. Seasons for serving, or prepares sauces. Makes stocks, soups, chowders broths, fricassees, and stews in steam kettles or pots. Prepares food for cooking or serving by dicing, carving, chopping, grinding, mixing, etc., using hand kitchen tools, and powered equipment. Applies knowledge of weights and measures in applying standard recipes. Prepares stuffings of bread or other ingredients to fill in meat, fish, or fowl for baking or roasting. Garnishes platters and large serving dishes. Loads and portions food into trays, serving dishes, steam tables and food conveyors. May be as- signed to serving lines to assist in final food preparation by portioning, carving, grilling, or serving menu items as required. Adheres to sanitary food preparation and serving practices, and assures that food prepared and served is in best condition. Cleans equipment or working area, incident to above duties. Carves food for individual servings. Arranges, decorates and garnishes food trays. Assists lower grade cooks in routine food preparation and kitchen cleaning duties.
