6.職務内容 Duties Presses and finishes dry cleaned or washed articles of wearing apparel, drapes, curtains, furniture covers, etc. made of silk, wool, rayon, nylon or other natural or synthetic fabrics, using various special presses such as utility press, shoulder steamer, topper, puff ironer and garment finishers. Examines garment to determine fabric and type of finishing required. Regulates pressure of pressing head. Stretches garment out and spreads evenly on buck (bottom half) of press. Moves pedals or hand controls to lower pressing head onto garment and to admit live steam to either or both buck and head sufficient to heat, moisten, and soften article without shrinkage or damage. Releases pressure after proper time by raising head, using pedal or hand lever. Moves valve lever to allow steam to escape from buck and rise through material. Brushes surface with whisk broom or brush. Steps on vacuum pedal to allow cool air to be drawn through buck and remove steam and moisture. Hangs garment on hanger and places on rack to be delivered to appropriate employee for assembly. May use steam hand iron to finish especially delicate articles of silk or synthetic fabric. May, occasionally, press washed, damp garments of linen, cotton, etc. on the above equipment, without applying steam. May stretch garments to original size during pressing, if shrinkage has occurred during dry cleaning.
